Cole Walters joined the meeting to ask the Board to consider giving the Economic Development money generated by the Local Option Sales and Service Tax to the cities with economic development. The communities would like the funds divided with Bedford, Lenox, and New Market all receiving 10% for the funds. Taylor County receives \$25,000.00 annually for Economic Development.

Walters also discussed the possibility of an internet project in the City of Bedford.

The Board tabled the Conservation purchases due to director illness.

The Board approved the claims to be paid.

County Recorder Rick Sheley joined the meeting to present his FY23 budget ask.

County Attorney Spurrier joined the meeting to discuss the purchase agreement with Donnie and Shannon Weed for the Purple Palace Building.

Treasurer Dana Davis presented the Semi-Annual Report that will be published in the paper. She also presented her FY23 budget ask.

Auditor Murphy presented her FY23 budget ask.

The Board tabled any decision on jail and booking fees.

Fitzgerald made a motion seconded by Horton to adjourn the meeting. Motion carried 3-0.
